(<https://review.management.ntu.edu.tw/page.aspx?pid=24&lang=en>). Reviews will be based on criteria including topics significance, relevant literature, research questions, methodological rigor, analytical quality, and coherence of argumentation.

### **Submission Requirements:**

- Manuscripts need to be written in English
- Please ensure that the full-text manuscript is anonymous
- Use 12-point Times New Roman, double-spaced, with 2.54 cm margins
- Maximum length: 15,000 words
- Submission format: PDF
- Note: Authors are responsible for all travel and accommodation expenses and accepted papers need to be presented at the Conference
